Public Comments

Port Account Tripp stated there was a request for public comment from the PBA. The PBA shared their report as a public comment.

Commissioner Comments

Commissioner Singer expressed his frustration over the accusation of use of picnic table and chairs on the docks.

Commissioner Green said she has been following cases with COVID and the numbers are alarming this month. She encouraged everyone to continue practicing social distancing and wearing masks.

Discussion of PBA Report

Commissioner DeSalvo reminded everyone that the Port has been extremely limited to essential business during COVID, which is why the board has not been discussing topics like the pump out boat. Once we get farther past COVID and back to a normal lifestyle we can start discussing those things more (unless the board wishes to discuss them sooner). We are by no means letting any of that go, there is still a full desire to get our own pump out boat. He also wanted to reiterate that the Port already has policies regarding people's boats. If there are changes that should be made about the policy manual, we can discuss and make changes; until then, all the policies are in effect.

Commissioner Green inquired about the frequency of inspections, and how they are tracked. Port Account Tripp stated inspections are done when boat arrives in the marina. Annual inspections are done for live-aboards, and inspections are done when anyone has a new vessel. If there is a boat experiencing electrical problems, oil leakages, etc., an inspection will also be done.

## A RESOLUTION OF THE COMMISSION OF THE PORT OF POULSBO AUTHORIZING PUBLIC SALE OF THE VESSEL

<u>WHEREAS</u>, the Port of Poulsbo has secured the vessel identified as 1980 – 36' Wood Cabin Cruiser HIN-WNZ07342G717 pursuant to RCW 53.08.320 and the Port of Poulsbo's rules and regulations for the vessel owner's failure to pay charges owed.

<u>WHEREAS</u>, ninety (90) days have elapsed since notifying or attempting to notify the vessel's owner that the vessel has been secured, and pursuant to RCW 53.08.320, the vessel is conclusively presumed to have been abandoned by the owner.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Commissioners, Port of Poulsbo that the vessel 1980 – 36' Wood Cabin Cruiser HIN-WNZ07342G717 shall be sold at public sale by authorized Port personnel to the highest and best bidder for cash per RCW 53.08.320. A minimum bid in the amount of \$2,041.00 is established for the auction to discourage the future reabandonment of the vessel. If an opening bid is not offered, then the Port Manager is authorized to reduce the minimum opening bid.
