Call to Order 10:00am

#### **Process for Commissioner Appointment**

This meeting is to discuss appointment for a new Commissioner at the Port of Poulsbo. Port Accountant Tripp started by sharing the documented process. The Port received notification from Mark DeSalvo on July 14<sup>th</sup> that he was resigning his Commission at the Port. At this time the current board must appoint a new commissioner by October 12<sup>th</sup> 2020. If the board does not appoint a Commissioner by October 12<sup>th</sup>, the Kitsap Commissioners would appoint someone. Port Commissioner Singer and Commissioner Green would need to appoint someone within 90 days. The Commissioners can pool together applicants and discuss the applications during an executive session. Interviewing those applicants would have to be done in a public meeting, as well as making the new appointment (RCW 42.30.110 Subsection 1-H). That position would able to serve until November of 2021, and then if they want to continue, they will go for reelection at that time.

After brief discussion, the following timeline was agreed upon by the two Commissioners:

Friday, August 7<sup>th</sup> – Application deadline Thursday, August 20<sup>th</sup> – Interviews in the form of a public meeting September 3<sup>rd</sup> – The appointed Commissioner will be announced

Announcements will be made on the Port website, the Port of Poulsbo bulletin board, and a newspaper ad. Commissioner Singer wanted to make it clear that all applications must be turned into the Port office. Qualifications needed to apply are as follows: applicants must be registered and residing in the Port District #12 boundaries and be a registered voter in Kitsap County. The qualifications to be selected are based on interview questions presented at the time of the interview, and interview questions will not be made available prior to the interview. Applications in the form of resumes will be accepted. Once an application is submitted, it is to be made public and will be available to the public. The Poulsbo Boater's Association will also post the announcement via social media.
