Unfortunately, a small fuel can was left in a compromising position in the sink and because of a heater that was on, the warmth expanded the container and fuel was dripping out of closed caps and vent & spout and went down the drain and straight into the water. Again, I want to take this time to address changing our policies in regard to containment in the marina with fuel cans. I know we cannot prevent all fuel accidents, but if we come up with a better solution than what we currently have I believe it would help keep your marina cleaner & keep us in compliance with other programs the Port is involved with. If you support the goal for a clean marina this would be a modest step forward for the marina.




