Call to Order 7:01pm

Commissioner Comments

Commissioner Pfeil said a lot of good things are going on. Judging from all the boats in the marina, the Port is off to a good start in the boating season.

Commissioner Lawrence said the Tacoma Rendezvous has 20 boats at the marina. The fuel barge is being fine-tuned. He signed off on a permit for E & F Dock last week. The bad news is the inspector came out and gave a slap on the hand. Other than that, E & F Dock are open. The breakwater power switch is holding up. A company came out to look at it and the technician broke a brand-new switch. The replacement is on its way. The breaker hasn't tripped. He has been working with staff to improve efficiency. The MOLO reservation system is up and running. There was a small fuel leak that took six hours to find and contain. Commissioner Lawrence wants to secure a 10' inflatable dinghy for \$250 to expedite travel to and from the breakwater for money collection. He will loan his own electric motor so the staff can use it on weekends when no maintenance crew is available.

Commissioner Lawrence said there are other rendezvous coming in. There's a rumor that the Viking Ship Valkyrie is closer to Coast Guard approval. Hopefully it'll be here in time for Viking Fest.

There was no report.

Craig Muller, C-11, likes Commissioner Lawrence's idea for harbormaster pay. Pay raises can come in increments over a timeline as performance is demonstrated.

30 Day Notice Waiver for Licensee

A request was received for moorage cancellation on 12/10. The routing sheet was received on 1/20 and returned 1/21/25. The harbormaster said due to extenuating circumstances, the 30-day notice should be waived. This requires board approval. Port Accountant Tripp said the board approved the action request in April 2024. The particular slip, C33, was charged as a 50' slip even though the slip is 64'x15'.

Accountant Report

There was no written report.

Port Accountant Tripp received documents from the Kitsap County Treasurer's Office. She will be on vacation next week and will not be available. There are numbering errors on the ETF Policy and the Public Records Policy Procedures. There will be two resolutions to amend: Resolution 2025-03 for the Public Records Procedures and Resolution 2025-04 for the ETF Policy. E & F Dock will be finalized at the end of the month. There are still a few items to complete and there are wait times on hardware. MOLO issues have been ironed out and there's a final plan to get it going. She said she spoke with the Port of Brownsville and will be reaching out to the Port of Kingston for staff training that needs to be done.

Port Accountant Tripp will have a meeting with Boat Geeks tomorrow about advertising. The rate will stay the same and will do a video, free of charge, for the Port website. She was contacted by the Recreational Boating Association of Washington, and they would like to do a presentation at the April 17th meeting. They'll be bringing a pump out boat that will be moored at the Port. One of their members will be traveling and respectfully requested to be put at the top of the agenda.

Commissioner Pfeil said Mr. Dana is requesting his late fee be returned because he was unaware his monthly rate had increased. Port Accountant Tripp said three notifications went out during third quarter of 2024. Statements also go out each month.

Mr. Clay requested moorage at the Port. The board discussed his history of running into other boats.

Commissioner Pfeil read aloud an update for permanent moorage. Please see attached.

HDPA Video Partnership

Commissioner Green doesn't know how to get ahold of them. Port Accountant Tripp said we might not need to partner with the HDPA. We can see if we need to reach out again if other attempts aren't successful. We can also utilize the use of personal drones.

Lease Agreement

Port Accountant Tripp said the three-year lease agreement was for Washington University. She needs to know if the board wants to do a month to month for the Sea Discovery Center (Marine Science Center). Instead of the full rate, it was offset with the boathouse moorage, \$1545/month vs \$2100/month. She said she'll run the numbers and report back to see if month to month is preferred unless a yearlong lease makes more economic sense.

MOLO Website Reservations

Port Accountant Tripp said this is being fine-tuned and shouldn't take very long.

Employee Schedules and PTO Request

Kelli and Ana are the only requests for PTO at this time. Employee hours are posted and are aware of the expectations of their working hours. PTO will be taken in one-hour increments from now on. Time clocks will be changed. Port Accountant Tripp said a seasonal employee will be hired for guest moorage toward the end of April.
