Commissioner Comments

Commissioner Lawrence said it was an honor and privilege to be on the board and thanked everyone for his elected position. He will do the best he can for the Port and the lessees. He wants to keep things going and make them better. There is something good at the Port of Poulsbo and he wants to keep it that way. He's looking forward to working with everyone.

Commissioner Green welcomed Commissioner Lawrence to the board. Winter is finally here, so be sure to secure boats in preparation for the weather.

Commissioner Singer thanked everyone for last year and their input toward the Rules and Regulations. He said the Port of Poulsbo has one of the better amenities because the Port is in a protected bay. A lot was accomplished last year. This year the board is looking at expenditures and where the Port is headed for the future. He is looking forward to future improvements and more visitors thanks to the breakwater.

Public Comments

Rodney McVicker, Port district resident and commercial tenant, said he has been asked for years to promote the Port and to help bring in commercial boats. He met a gal with a boat that was built in Poulsbo who left and has since returned to Fisherman's Terminal. Rodney had recommended mooring at the Port of Poulsbo. After receiving his bill from the Port he felt bad for recommending her to the Port of Poulsbo, who is 35% higher in moorage than Fisherman's

Terminal. If Poulsbo wants commercial boats, they'll have to be competitive with Fisherman's Terminal.

Craig Muller read an article in the paper about the City talking about paid parking. People will still look for free parking and will wind up taking liveaboard spots. He's wondering about how the Port can monitor parking so a tow company can be called as soon as possible to get the cars out. He has seen in the past tow companies cruise around and tow illegally parked cars. A plan needs to be in place to prepare for such a scenario.

Stuart, lessee in permanent moorage, wanted to commend staff members Katelyn Cook and Carol Tripp for their informative, predictive, and proactive email communication. Many in permanent moorage aren't close to their boats and it's important to advise them on what's going on.

David Musgrove, Councilman at the City of Poulsbo mentioned helpful, recommended forward moving resources available regarding Robert's Rules of Order. Such short guides as Jurassic Parliament and A Great Meeting are very helpful and available as laminated pieces that can go on the table for easy reference.

Commissioner Responses to Public Comments/Discussions

Commissioner Green thanked Rodney for his feedback on rates. That is something for Port Accountant Tripp and Eugene to consider regarding commercial rates to be appropriate and competitive. She wasn't sure, when it comes to paid parking, if tow company patrols are a first

option. She thinks there must be parking tickets sited first. The Port needs to investigate who has the authority to write tickets. Commissioner Green has enjoyed Katelyn's activity on Facebook and appreciates Councilman Musgrove's advice and recommendations on Robert's Rules of Order.

Commissioner Lawrence appreciated Rodney's comment about rates. Parking is definitely a touchy subject and there's a lot to it. He appreciates and values everyone's input and time.

Commissioner Singer said commercial boats are important. He wants to consider what can be done to encourage and support the commercial community at the Port; he wants to consider an ongoing agenda item for continued discussion and improvements. Parking is a hot topic, and he sees people parking without permits every day. Addressing the parking topic is something the Port has done in the past and will continue to do in the future. While Robert's Rules of Order are part of the habit at the Port, a large part of the meeting is discussion. Open discussion isn't always allowed with Robert's Rules of Order and people's input is important. Discussion needs to be encouraged.

Manager's Report

Public Comments & Requests for Future Agenda Items

There was a public comment saying the people who hold the parking passes are the ones who have the most incentive for patrolled parking. They wondered how it might be possible to get those people to assist in ensuring parking is patrolled. It would be good to empower the lessees in some way.

Aaron Wenholtz said parking is a hot topic and it's only going to get worse. It isn't fair or right to place responsibility on the lessees. It will only be good for the lessees that want to help. He sees it becoming an issue between people that doesn't need to happen. There's no enforcement happening at this time, and it would be nice to see some sort of protocol within the employees and management on enforcement of parking.

Commissioner Comments

Commissioner Lawrence said people think the parking rules don't apply to them. He encouraged everyone to protect their boats in preparation of the pending deep freeze. Bundle up and stay safe.

Commissioner Green thanked everyone for coming to the meeting and for having great discussion. She felt like things were productive. She's looking forward to seeing what the new year brings as a Commission.

Commissioner Singer wished everyone a happy new year. The breakwater is opening, and he expects to see more people, along with more boaters and commercial boaters. The parking issue has been discussed a lot and it is upsetting when people don't follow the rules. It isn't the lessee's responsibility to patrol parking. Parking is a continued issue at the Port. Regarding the grand opening of the breakwater, he thinks the Port should host a contest to see who the first boat will be. Port Accountant Tripp is nervous about the new budget. Rates are going up because of all the projects the Port has done, and everyone is trying to keep up. Everything costs more now, and the Port is providing a service. The Port Attorney is looking at the Rules and Regulations. Once the document is available the board will review any issues.
