Commissioner Comments

Commissioner Singer said he was glad to be back in person rather than on a Zoom call. The sun is coming and he's looking forward to that. He's working on something for the boathouses, and he hopes everybody comes out and enjoys their boats.

Commissioner Green noticed the "Uff da!" wall mural between The Loft and Slippery Pig. She knows know there are other places downtown interested in wall murals. She was informed by Kitsap Rowing Association that the landlord is not renewing their lease and they are in need a new place for their equipment as of September 1st.

Commissioner Rose said he appreciates forbearance back last Friday night after he learned his sister passed Thursday night. Due to the changes in his life, and the need to put family and health first, he has resigned his position of Chairperson on Tuesday.

Councilman Musgrove said the City had a review at Council last night of the last year and first quarter of this year. The tax revenue for the previous year and the 1st quarter of 2022 are up 10% overall. The majority is now construction and retail sales are down 4%.

Commissioner Responses to public comments/discussions

Commissioner Rose wants to continue encouragement about doing heavy maintenance and repair. These projects are not designed to upset people and the aesthetics of the marina.

Commissioner Singer wondered if there an election in the future for the Mayor's position and supporting the City and the Port?

Commissioner Green wants to consider making Zoom meetings a continued possibility for those who would like to attend but aren't always in town for the meetings. She is aware the multipurpose room doesn't have a solid Wi-Fi connection. She wonders if meetings at City Hall might be possible to consider as a board. Commissioner Singer said if people are interested in it the board should explore it; there's no reason not to consider this if the board isn't negatively impacted.

4/28/22 thru 5/5/22 pretty quiet on the home front.

5/6/22 - Marina hazmat day unfortunately because of the rains there was only a few participants this time around. We collected about 7 gallons of oil and ½ gallon of oily bilge water and 16 flares.

5/9/22 – I will be sending out letters around 5/27/22 to all the LA and BH owners so we can start scheduling their annual inspections and have them completed by end of August.

5/11/22 – Met with Torey Grandt from Port of Kingston. We will be pairing up with them to have both staff go through overboard training.

5/16/22 had a message from a person that had purchased a boat from within our marina and was trying to take it out, but got caught in the winds and ended up on the crossing dock between A&B. The new owner was able to get a help to have it moved back in to slip. I explained to him the boat must be removed by May 31st. as the tenant has given notice and I have already filled the slip.

5/18/22 – Would like to inform the board for the last year I have been taking a continuing education program through University of Alaska SE Ketchikan. The Program is Ports, Harbors, Marinas. I would like to say Thank you to the Port for the opportunity to take advantage of the Employee Education benefit that is offered. I completed the program with a an overall 95% (A-). (Classes taken are attached). *It was developed in partnership with the Univ. of Alaska Southeast, Pacific Coast Congress of Harbormasters and Port Managers (PCC). Alaska Association of Harbormasters and Port Administrators, Harbor Authority Association of British Columbia, WA Sea Grant and the CA Assoc. of Harbormasters and Port Captains.*

5/23/22 - received only 2 notices and have already been filled.

5/23/22 - updated website with waitlists

5/25/22 – updated website with new resource for boaters. Boat Safe NW w/ Luke Roberts – boating training classes

5/27/22 – sent out notice to the LA & BH owners to schedule their annual inspections. For the boat house owners, it was explained starting this year we will be not only inspecting the BH but the vessel that is registered inside. These inspections are expected to be completed by August 31^{st} .

6/1/22 – I have been receiving several complaints in regards to licensees and non; parking in spots without permits, parking more than 48 hours allowed in same spot, not contacting office to get extended stay pass to park up at Jensen. A car was towed today because it had been there all weekend and there was no parking permit, no identification and several licensees I spoke with did not recognize the vehicle.
