#### **Commissioner Comments**

Commissioner Lawrence said he attended the quarterly All Ports meeting in Kitsap County. Representative Greg Nance (23<sup>rd</sup> Legislative District of Washington State) was in attendance and is a Kitsap County local. Representative Nance is doing what he can to help the Port and transportation is his focus. He did get an earful from every Port about all the litigation Ports go through just to prove anything. Also in attendance was a representative from the WPPA, James Cockburn, Government Relations Manager. James said to give him a call if anything is needed.

Commissioner Green wanted to congratulate the Kitsap Rowing Association, awarded by West Sound Magazine's "Best Of" for "Best Athletic Club." Viking Fest is also coming up.

Commissioner Singer thanked everyone for attending and participating. It's been good working with everyone. He's ready for more sunny weather.

#### **Public Comments**

Aaron Wenholz, D Dock, had a comment on the survey policy. He argued the present Port survey policy is hurting more than serving the Port. There's no one qualified for the survey findings, and the surveyors often miss critical items. Quality tenants have been turned off by the policy and have told him as much. He knows there has been trouble filling winter moorage and short-term tenants because of it. He suggested training an employee in identifying boat hazards, giving thorough inspections, and using the survey policy as a backup policy.

Gary Rutter, AA-15, believes the Port needs a harbormaster rather than an executive director; someone who is working to take care of the Port.

#### **New Business Items**

#### **Commissioner Responses to Public Comments/Discussions**

Commissioner Lawrence said, regarding the job title, the Port is looking for more than a harbormaster. There is a full description ready of what the Port is looking for. There are several things Port Accountant Tripp has been doing (such as securing grants), that far exceed a harbormaster's responsibilities. The Port is looking for someone that will walk the docks, go above and beyond, be out there, and throw ropes if needed.

Commissioner Green is hoping to get a solid candidate this time and get it right. The title allows the board to receive better candidates. One thing about the job market right now is if the person doesn't put in the right keywords, they may never make it as a possible candidate. She's glad the Port is utilizing an organization that's helping make sure we get quality candidates.

## Accounting Report -

No report at this time.

## **Business Report –**

The hiring of the new Port Manager/Harbormaster is moving along. I had a lengthy discussion with Cliff from Protham. The PBA Survey was forwarded to Cliff. Protham is working on preparing documents. I sent an email to the Commission earlier today with the suggested dates for stakeholder meetings.

Security services have been hired for Vikingfest. We will have security personnel on the breakwater, permanent moorage and guest moorage for the weekend.

Kaitlyn has been working hard on the new 'Guest Moorage Training Manual.' It should be finalized before the end of the month.

Met with Poulsbo Police Chief Harding and officer Zieman last week and confirmed the plans for 'Liberty Bay monitoring' and the future of the marine program. We also spoke about derelict vessels and the process to destroy them. Expect to see the Poulsbo Police boat out in Liberty Bay. They will be updating the list of vessels that are anchored in the Bay.

The 'Ice Guys' got the new ice machine delivered. It should be up and functional by Vikingfest, at the latest. There will be NO CASH taken at the machine, it will credit/debit only.

There was a request from Kitsap Rowing Association to appeal to the Commission to reduce their monthly electrical charge. While I understand the financial burden this causes the club, I was very upfront that, from a business perspective, this is a necessary fee to help the Port collect funds to rebuild it's electrical systems and I would not endorse removal of the \$42 monthly fee.

Pierce County/CVA Rep – Jeff Barney, Watershed Planner for Pierce County. I have committed the Port of Poulsbo to a 2 year contract, at an annual cost of \$5,000. This contract will provide Pumpout services for the floating restroom and Pumpout services to transient boaters at no cost during the busy spring/summer season.

Port of Brownsville maintenance worker, Tim Herman spent Wednesday with our new maintenance supervisor. Several topics were discussed and Daryll appreciated the information that was provided. Daryll stated that he'll be making a few changes to the fuel dock operation; mainly in the form of maintenance logs, fuel spill supplies and regular maintenance.

Maintenance staff will be attending an all day training on Wednesday, May 8th. There are new requirements for 'Class 4 Fuel Docks' and the Port of Kingston has offered to organize the event.

WSDOT inspecting seaplane float and notified about E&F dock project. We will be inspected on Monday, May 13<sup>th</sup>.

Kelli and I will be doing interviews starting tomorrow for the following positions:

- Guest Moorage Coordinator Breakwater
- Seasonal Guest Moorage Attendant

Several policies are in need of review. I will have the following policies ready by the end of the month:

- Handbook of Poulsbo Guest Moorage Regulations (expired)
- Guest Moorage Cancellation and Refund Policy (expired)
- Guest Moorage Reservation Policy (new policy drafted)
- Breakwater Policy (new policy drafted)

This is a partial list of policies requiring review. There are several other policies that have 'expired' and require review.
