Commissioner Comments

She's very confident the more everyone gets involved, the more things are moving in the right direction. She wants to continue working together, move out of the red and into the black and have proper management.

Commissioner Lawrence thanked everyone and the staff. The weather is starting to get nicer and he's seeing more boats over the weekends. Multiple rendezvous are coming up and quickly getting to capacity.

Public Comments

Craig Muller, C-11, looked at the minutes and it looks like the Commissioners have picked another Commissioner. He thinks it would be nice to see a bio come out from the Port to introduce the new Commissioner.

Doug Brusig was banned back in June of 2021. He's hoping to be reinstated and allowed use of the marina. He's also a captain for the Virginia 5 and has been talking to the Heritage Museum. He's hoping something can be figured out tonight.

Marina Software

Commissioner Lawrence and Port Accountant Tripp had a conversation with Molo last Thursday. There are a lot of things they can adjust for the Port to make sure things are aligned. Port Accountant Tripp said Sharper MMS is \$899/month (\$10,788 annually). It doesn't make sense to do that. The annual cost for Molo is \$5,878.08 and the program isn't being utilized to its full extent. They were provided with a walk through on reservations and it took less than two minutes. It's very clear that no one has received proper training. There are safeguards in place to prevent overbooking slips, which is significant compared to what Dockwa has. There are also multiple touch automated emails that will save staff time while improving customer service.

Commissioner Lawrence advocates for Doug and remembers Thomas Rose expelled him but also wrote a letter of recommendation after nearly four years. It would be nice to bring a piece of history back.

Recruitment for Port Manager

Commissioner Green asked what advertising looked like. Advertising includes LinkedIn, Careers in Government, and several others. Advertising would cost \$3255.22, and some prices may have increased from the previous year. The Port will not reimburse any travel expenses. One recommendation from Prothman's is to hold off on deciding until there is a third Commissioner, which will be addressed at Monday's meeting. The job description needs to be updated to reflect a business focus, business minded with understanding of profits, risks, etc.

Guest Moorage Rates

Commissioner Lawrence is receiving a lot of phone calls from people. Port Accountant Tripp said the last harbormaster decided the rates would be sufficient at \$2.24 on E & F Dock, and \$2.00 on the breakwater. The next closest is \$1.90 in the general area. Yes, the higher prices would allow the Port to make more money, but rates may deter people from coming in. There was discussion over lowering everything by 25 cents in each category. The consensus was it's too soon to make any adjustments at this point. Rates only increased at the beginning of January and the Port needs more time to monitor activity and collect data. The agenda item will

remain on the backburner and the Commission will continue to monitor information as it becomes available.

Public Comments & Requests for Future Agenda Items

Commissioner Green said to add "Lease Agreement" to the March 6th meeting.

There was a comment from someone who recommended using Bryan Kilpatrick again for promo videos for the Port. People will be willing to pay the rates if the Port shows the public what the improvements are. Hopefully someone will have the skill of social media, know what the goals are, and how often to post. The staff should respond to the public to help them realize why rates are higher and what the improvements are.

Another comment was made asking if Monday's meeting was open to the public.

Commissioner Comments

Commissioner Green is glad to hear Commissioner Lawrence had the same lack of response from the City that she received. She's looking forward to getting a third Commissioner on board to help with the workload. She's also looking forward to making that announcement on Monday. She believes things are getting done and the Port will see a lot of positive changes.

Commissioner Lawrence thanked everyone for showing up. He's looking forward to the boating season. He reminded everyone to stay aware of their surroundings and aware of other people. There was an article about a gentleman in the City's waters who was an unregistered offender on an unregistered boat. Look out for each other and do the best you can. Hopefully the City will start patrolling the waters more.

Port Accountant Tripp said the pump out organization presented themselves at the City of Poulsbo to ask for money for a grant. All City Council kept asking is, "Why are you here? We're not the Port of Poulsbo." The City doesn't understand the anchorage is their jurisdiction. The Port committed to \$5,000 of pump out services for the bay for clean water and picked up the tab for the City. There's a gap that needs to be filled in, which is done by the grant. Port Accountant Tripp said they organization did get the grant for a new boat. They will be looking for moorage for the vessel and where they can buy fuel for the vessel. The organization will want to give a brief presentation at a future Port meeting. A lot of liveaboards use the service. The Port does have to pay to have the floating restroom pumped out during the offseason, so this may allow an opportunity to exchange moorage for pumping out the restroom.

Accounting Report – February 20, 2025

Accounting Report -

The Summary of Financial Statements for the month ending January 31, 2025 is attached to this report and were emailed to the Commission on February 12th.

For the month of January, there was a net loss of (\$27,217.46). The loss was attributed to 4th Qtr payouts for payroll taxes and leasehold excise tax. There was a small payout of \$6,558.00 for the E/F Dock project. A 'retainage' balance is being held by RCO, in the amount of \$54,800 and will be released when the electrical inspection has been completed, and the project is marked as completed by RCO.

Resolution 2025-03, for an interfund transfer from Liberty Park Fund into the City of Poulsbo/Port of Poulsbo Waterfront Improvement Fund, has been completed and was emailed to each Commissioner earlier this week. This is an annual transfer which is typically completed in the 3rd or 4th quarter of the year. Since the Port was in the process of completing a large capital improvement project, the funding was delayed by a few months. Expect another interfund transfer later this year for the year 2025 matching contribution. *MOTION NEEDED TO PASS RESOLUTION 2025-03*

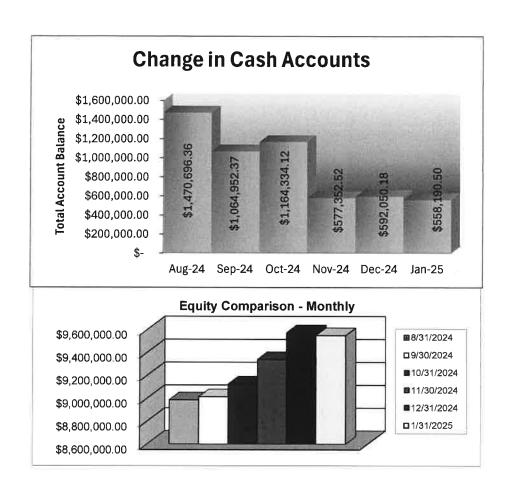
