Call to Order 7:00pm

Commissioner Comments

Commissioner Singer had no comment.

Commissioner Green said Yulefest is coming up on Saturday, December 7th. The Vikings will have their bonfire at 4pm. Santa will be downtown every Saturday and Sunday, leading up to Christmas. The Yacht Club will have their lighted boat parade on December 21st. Feedback has come in that the board needs to have some true delegation and follow up points of contact for calls to action at the end of the meetings.

Commissioner Lawrence hopes everyone had a good Thanksgiving. He will be attending Yulefest and participating in the light parade as well. There was a workshop, and we are trying to work on things together to get everything updated. He appreciates the patience from everyone. The board is invested in the Port and all the money that comes in goes back into the Port. There will be hiccups and we're doing everything we can to make things move forward.

Public Comments

Jeff, volunteer consultant, said the Port of Poulsbo is an important marina. The breakwater and relocation of the fuel dock were wonderful improvements. The reservation system is plainly terrible, which he says as a boater. Reservations need to be easily made available and accomplished by Dockwa for guest moorage. The Port Director at Port Ludlow will gladly answer any questions. The comp plan from 2022 touched on remote payments, which would save time and enhance revenue. The fact that power may be unavailable on the breakwater is crazy; it discourages people and groups if they can't have power. Just get it fixed. An alarm system that would alert staff by text if power fails would fix this. The website needs work and updates. Someone needs to stay on top of social media. Hire a consultant if needed. Those slips need to be full year-round and to sell more fuel. The fuel dock should be open until 6pm. Give Daryll the tools he needs to succeed. There are too many excuses about why things can't be done. This culture needs to be positive, and the Port will prosper.

Nico Jensen, D Dock, said there's still trouble with signage. It's hindering communication and it needs to be addressed. There is a marketing strategy of "if you build it they will come" approach. Proactive marketing plans could help fill slips. Promoting guest moorage and breakwater slips would help. Partnering with Yacht Clubs would help. Social media needs to be updated in real time. To help drive progress, 1-3 action items need to be assigned to staff and Commissioners. Without outreach, time, and resources, potential revenue is wasted. She'd like to see "proactive marketing" added to the future agenda. She wants to see the Port utilize the improved facilities and make the Port of Poulsbo the first-class destination it claims to be. The

Port can only fail through mismanagement at this stage. If the Port starts now with positivity and educational campaigns, she thinks annexation is still several voting cycles away.

Poulsbo Boater's Association

The association gave their report.

Old Business Items

Inclement Weather Policy

Harbormaster Trask renamed the policy to "Closure Policy." It includes inclement weather and other safety issues. Everything else in the document remains.

Motion: Move to approve the Closure Policy as presented.

Moved by: Commissioner Singer Seconded by: Commissioner Green

Motion passed unanimously.

Reservation Policy

The biggest change is on page two of the reservation policy, and includes no reservations are permitted for Memorial Day, Labor Day, and Viking Fest. Reservations can be made the same day before 11:30am of that day. Everything else reads the same and Harbormaster Trask would like to see the Reservation Policy approved today.

Discussion followed in support of allowing reservations on said restricted holidays. Port Accountant Tripp said if holidays are open for reservations, it'll need to be approved by RCO. If reservations are no-shows, they still need to be charged. Reservations can be limited on holidays, and some can be made first come, first serve.

Commissioner Singer believes reservations for holidays should be live. Full payment should be due when the holiday reservation is made without reimbursement within the timelines allotted for cancellations.

Motion: Move to table the Reservation Policy until comments are reviewed tonight.

Moved by: Commissioner Singer Seconded by: There was no second

No vote was taken.

New Business Items

Commissioner Responses to Public Comments/Discussions

Commissioner Green suggested reviewing January to help save time. There will be a workshop on January 6th at 10am. One agenda item will include a marketing strategy plan. Another agenda item will be communication and will also include social media. Signage will also be discussed. The kayak racks are not being utilized.

Commissioner Lawrence attended the Bloody Mary Crawl. He watched a boat loop around before tying up at a dock. He tried to tell the boater the Port was closed. He saw the boat loop back around to tie up at the dock again. He said we're doing what we can, but we can't just make people stop doing what they're doing. There are things we're working on. Policies are outdated or soon expiring. We've been taking care of them and Harbormaster Trask is addressing them. Once addressed, the Commission can start working on them. In the past, people started doing things they wanted to do. He's going to get the systems written and it'll take some time. Unexpected things have popped up that the board is trying to deal with.

Public Comments & Requests for Future Agenda Items

Jeff would like to see the board continue to talk about Dockwa and be able to proceed with vetting Dockwa. He also wants to see the board get into the mode of how things are going to get done and kick it into gear. He hears a lot of reasoning about why it can't be done. It can all be done. Everyone needs to work together. It needs to be positive attitudes and get things going.

Aaron Wenholz, D Dock, addressed his comment to Commissioner Lawrence. His comment about signage and the boater tying up to the dock even after being told the Port was closed is not an excuse to not do what's right. Commissioner Lawrence's attitude perpetuates things not happening. Signage will help relieve the Port of liability and will communicate with the public.

Nico Jensen, D Dock, said signage is about risk mitigation. Not about people who are poaching moorage. The point is your sign is going to protect you against incidence or injury when you don't have any signage or adequate signage posted. The signage doesn't say anything that protects the Port. Someone who shouldn't be there can sue just as easily as someone who should be there. It's about protecting the port and that's disheartening when it's known there's limited reserves.

Damien Clark offered to rent the spot the kayaks are in as a moorage slip. There's ten years of lost revenue there. He will rent the spot and be done with it.

Commissioner Comments

Commissioner Lawrence wasn't trying to razz on signage and getting things taken care of. Port Accountant Tripp has been doing more about signage, and he isn't trying to shut anybody down. The Reservation Policy is nearly done but isn't quite ready to sign. He wishes he could do it faster. He listens and there are workshops and meetings. Sometimes it won't be how everyone wants it. There are steps that have to be taken, and those steps take time. We are all working together.

Commissioner Green addressed the PBA's questions. Harbormaster Trask has already preemptively responded to some questions. He will send the new organizational chart on Monday. We do have our five-year comp plan. It is something to collaborate on with Harbormaster Trask and Port Accountant Tripp to be broken down year by year. Nico said she would like to see general goals for the future, how the Port plans to get there, and how and when maintenance will happen.

Commissioner Lawrence said Commissioner Singer has done a lot for the Port and wishes him the best in the future.

Commissioner Green said she is sad to see Commissioner Singer go, but she understands.

Accounting & Business Report - December 5, 2024

Accounting Report –

The Summary of Financial Statements for the month ending October 31, 2024 has been completed and are attached to this report.

For the month of October, there was a net gain of \$111,572.71 which is due to real estate and personal property taxes received in the amount of \$118,342.64. There were no payments made for capital improvements project for this month.

We have a quote from 2 contractors to complete some needed maintenance on the fuel dock. The lowest responsive bidder was SME Solutions, LLC in the amount of \$32,765.95. The two quotes that we received were as follows:

- Saybr Contractors Inc. \$60,268.02 (inc WSST)
- SME Solutions, LLC \$32,765.95 (inc WSST)

Additional information was requested from SME Solutions, and it has not been received as of 12/05/2024 @ 1:30 pm. If the Commission would like the fuel dock to open before January 2, 2025, I would suggest that the Commission approve the low bid of \$32,765.95 with a contingency of \$15,000 (plus WSST). This will allow for the completion of the project without delay or causing a special meeting occurrence. **BOARD ACTION REQUIRED.**

End of year 'housekeeping' issues-

- 1. Resolution 2024-09 was drafted and requires approval this evening. This resolution was emailed to the Commission earlier. RCW 39.56.040 requires that warrants (checks) be presented 'within one year of their issue.' There are three warrants that have exceeded the time period and have been listed on the resolution. **BOARD ACTION REQUIRED.**
- 2. There is one remaining individual who has an outstanding balance on their account, and it has been submitted to our collection company. At this time, I do not recommend writing off this account as a 'bad debt' until it has been in collections for 6 months or more. There are no other accounts to write off as bad debt, therefore a resolution is not required.

Lastly, as a result of completing an **unanticipated** replacement of the Port's Fireline in 2023/2024 in the amount of \$429,156.01; combined with, a higher than estimated, breakwater replacement in the amount of approximately \$980,000 in 2023/2024, the Port was hit hard financially.

We now have another unanticipated expense of approximately \$49,160.95 for fuel dock maintenance and a repair to the Fireline, which is estimated to cost \$15,000. The Fireline was damaged by the floats grounding and damaging the connector.

These are the reasons for the cash shortfall that we are in currently. Assuming that a Cash Flow Projection was not done is incorrect assumption.

In addition, grant funding was approved for the E/F Dock project in 2023, and the Port started the process of moving forward with the project. Until earlier this week, the Port was waiting for \$464,186.28 in grant reimbursements from the State of Washington. We did receive one grant reimbursement of \$225,578.43 this week but the other amount is still outstanding, and I am hoping to receive it by the end of the month given delays because of the holidays.

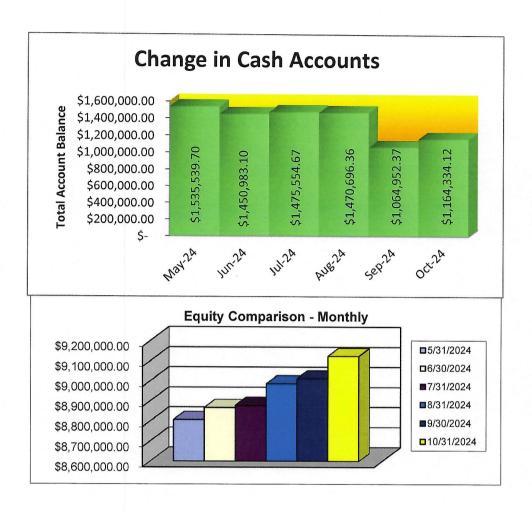
