Call to Order 7:00pm

Commissioner Comments

Commissioner Green shared fall festivities taking place, including the trick or treating downtown Poulsbo on the 31st, from 4-6pm.

Commissioner Singer was on AA Dock when the first 50' finger pier arrived. The Port is waiting on the 30' finger piers. It's been a long route getting to where things are now.

Commissioner Rose was encouraged by news that Eugene will be sharing during his Manager's Report toward the end of the meeting. He wants to focus on Rules and Regulations tonight. With the way things are going in the world, the Port has an opportunity to do good.

Public Comments

Jay said he is glad to be at the meeting and that the board is reviewing the Rules and Regulations. He agrees word adjustments are necessary and he does disagree with some things in the document.

Craig understands the need to update the Rules and Regulations. He feels that the topic should be put off until after the new Commissioner is on board. He also thinks tenants, lessees, and Commissioners should form a joint committee to discuss Rules and Regulations.

Thomas liked what was said about taking time to review the Rules and Regulations and thinks licensees and Commissioners working together is an excellent idea. It's wise to bring things to the public eye, too, because there are a lot of people who are anchoring out who are scared of the Port, and they shouldn't be.

Gary said everybody who signed the contract should get a chance to communicate any changes that go into the Rules and Regulations.

Paul made a comment, but the audio cut out.

Poulsbo Boater's Association

The association gave their report.

Consent Agenda

Motion: Move to approve the meeting minutes of October 5, 2023, and the warrants as read.

New Business Items

Commissioner Responses to Public Comments/Discussions

Commissioner Singer said, regarding documentation operations, each document has a review periodicity anywhere between 1-4 years. Now it's time to review the Rules and Regulations. He agrees with many of the PBA comments. Part of what happens in today's Rules and Regulations is everyone who signs a copy receives a copy. He encourages everyone, once the document is updated, and prior to it being updated, to follow the Rules and Regulations. The Port has employees sign an agreement when they're hired that states what they're allowed/not allowed to do regarding interactions they're allowed to have/not have when dealing with other Port employees, the public, and lessees. The employees are required to sign it and are held responsible to that document. Said agreement is stricter than the Rules and Regulations. Every employee is required to adhere to it. Everyone knows the Port has had issues with employees. The Port does utilize a legal document for its employees.

Commissioner Green clarified that any member of public is allowed to become a member of the PBA. Regarding Rules and Regulations, the board is only discussing the topic this evening. This doesn't mean the topic will be voted on. She isn't aware of what other notice is required than what has been provided for the discussion of the topic. She's glad the PBA gave their insight.

Commissioner Singer said the Commission cannot be at a meeting together unless it's an official Port meeting. The board has to start somewhere regarding Rules and Regulations, and that's why the topic is on the agenda: to discuss it.

Commissioner Rose thinks it would be wise to have a committee condense things down to a manageable report to provide to the Commission as a whole, so the board can act on it. It would be best to have it in a controlled fashion with the limited time the board has together. He would like to go through it and address things. He also looked at 25 individual Ports, both public and private.

Rules and Regulations Discussion

Eugene said there isn't anything in the Rules and Regulations that is detrimental. There are things that he's seen that aren't supposed to happen, but he can't do anything about it because there's no mention within the Rules and Regulations. There are people who have worked on boats and boaters can't afford to take their boats elsewhere to sand the railing, and they're trying to be clean about it. He needs help with knowing how to handle situations. If anything needs to change to make sense, that's all Eugene is looking for.

Commissioner Rose said he wants to focus on the items we have questions about or need to address. Commissioner Green said clarifying verbiage is a great idea. We will not condone offensive conduct. We need to give reference to the policy for employees and staff. Licensees must provide and maintain current contact information to the Port. Regarding board vessels, there needs to be a timestamped document demonstrating the Port's communication attempt with the boat owner. (*Audio was very distorted*.) Eugene said in the years he's been at the Port he has boarded one boat and that was to assist in tying it up. There was some conversation around fishing concerns. (*Audio from the first recording cut out the last five minutes*.)

Motion: Move to refer back to staff to collate and annotate changes and updates (*audio cut out*) via public input at a later date for final approval.

Moved by: Commissioner Rose Seconded by: Commissioner Green

Motion passed unanimously.

Public Comments & Requests for Future Agenda Items

Nico said, regarding Commissioner Singer's comment about the Port agreement with employee conduct, there's still no agreement between lessees and employees. The ball remains in the Port's court and the manager enforces rules with the employees. In the Rules and Regulations, the bad behavior needs to not be tolerated toward lessees.

There was a comment about a lot of talk regarding security and the burden placed on the Port to provide the best security possible. At the same time as those comments, it's also said that whatever the Port provides isn't sufficient while acknowledging sufficiency would be too restrictive. It would be helpful to figure out how to encourage the entire community to participate.

Aaron recommended sending out information about security events so the Marina is aware and paying attention.

(Audio was periodically distorted and difficult to understand; apologies for any missed comments.)

Commissioner Comments

Commissioner Singer enjoyed the meeting. He wants to continue enjoying the meetings and is looking forward to the Marina continuing to become cleaner and more organized.
