#### **Commissioner Comments**

Commissioner Singer thanked Johnathan Davis, liveaboard, who took the snow off the top of Commissioner Singer's canvas. He really appreciated that. He also appreciated everyone who attended (including the PBA and several others) the discussion about the Port Rules and Regulations. There was a lot of great feedback that will be provided to the rest of the Commission for final review. He thanked everyone who showed up.

### **Public Comments**

Craig Muller, C11, agrees with Commissioner Singer that everyone worked together and accomplished things during the Rules and Regulations meeting. He recommended the Port consider participating in a Port Rendezvous again.

Rodney McVicker, D-Dock, followed up with Fisherman's Terminal and the breakdown explanation of his bill. What he learned is they charge 25% less than what the Port of Poulsbo charges. They charge by the month, and by registered length.

Aaron Wenholz, D-Dock, liveaboard, appreciated the meeting today and thought it was great everyone was listening to one another. Frosty Fest seemed like it was a big hit and he saw a lot of action in the town. The people he saw participating in the scavenger hunt were not boaters, and he appreciated that. It was nice to see the old boat out working.

Dave Musgrove, Poulsbo City Council & Port Liaison, enjoyed the recent Port events. He suggested to Eugene that he, or a Commissioner, attend a Port Council meeting and provide a quick report during the three-minute comment section. The exposure would be great, and it would be nice for the City to hear what the Port is up to. He also announced last night at the City Council meeting that he is relinquishing his seat. A new Port Liaison will be reassigned at some point. He has been on the City Council and a Port Liaison for the last thirteen years. He's looking forward to what is next for him with travel and family.

## Maintenance: Eugene

- Maintenance is out on Breakwater pressure washing.
- 240v was added to bathroom building for ice machine coming approx. in March. Will be working on the water line as soon as possible.

### Guest Moorage: Jannese

- The weather on Saturday was a bonus! The marina looked amazing with the docks full of boats and the Carlisle II on the end of E Dock. So many happy people enjoying themselves. The Lions Club Bratwurst Fundraiser kept the mood of the event very lively!
- Friday evening, I worked at Western Red Brewery, helping with the glogg tasting, poker run & t-shirt sales. On Saturday evening at Western Red, I helped the scavenger hunt participants with their beading activity making bracelets & suncatchers.
- Throughout Friday and Saturday, we were overwhelmed by the number of people who expressed their gratitude and the happiness they experienced throughout the weekend, especially on a weekend in February. Several of them told me that they hadn't expected to spend as much as they did in the shops due to having to go into the shops individually to collect the beads!

## Permanent Moorage: Kaitlyn

- Permanent moorage has no current change we do have interest in the open slips however no one has moved forward with renting the slip.
- On a more positive note, social media updates. It seems the foot ferry was a big hit. With all the engagement we have had we have increased our page likes by 175% and gained 19 new Instagram followers. Our page visits for Facebook increased 47.7% and 61.80% for Instagram. We have had an increase in our reach across our platforms. Facebook, we have reached 20.3K people and Instagram has reached 564. Instagram is one of our less engaging platforms thus our reach is good and growing as we have historically very little interaction on our Instagram.

Accounting Report - February 15, 2024

I forwarded information to the Commission on February 7<sup>th</sup> concerning insurance coverage for the breakwater. I need Board approval/denial for insurance coverage. **MOTION NEEDED** 

I forwarded a revised 'Employee Cash Handling Policy' on February 9<sup>th</sup> which includes necessary updates, regarding requirements for the MOLO software. Page 3 has the only change in the policy. **MOTION NEEDED** 

The Summary of Financial Statements for the month ending January 31, 2024 was emailed to the Board on February 7<sup>th</sup>. Copies of this report are available this evening or can be accessed on our website shortly. (See attachment #1)

For the month of January 2024, there was a net loss of <\$409,118.01>. This was due to a \$474,901.89 payment for the breakwater construction.

The Summary of Financial Statements for the month ending December 2023 was amended and emailed to the Board on February 14<sup>th</sup>. Copies of this report are available this evening. There was a write off of multiple, small ticket items (office furniture & equipment \$4,104.01) which is no longer in service and a write off of obsolete software also (\$14,626.68 FSM). The total amount of write offs in December was \$18,730.69. (See attachment #2)

The detailed 'Actual vs Budget' for the year ending December 31, 2023 was emailed to the Board on February 14<sup>th</sup>. Copies of this report are available this evening. (See attachment #3)

The most significant shortages in 2023 were:

- 1. The lack of income from the breakwater due to the delays in processing our various permits
- 2. Permanent Moorage was under budget Tightened up 'D' Dock (short for 6 months), 4 slips have remained empty due to beam issues and/or depth issues, 'D' Dock slip (65') was vacant for 6+ months for the Viking ship.
- 3. Guest Moorage was under budget Boat nights were under previous years.
