Call to Order 7:00pm

Commissioner Comments

Commissioner Lawrence said he has started spring cleaning and hopes everyone else is getting ready for the changing season. He's glad to see everyone in attendance.

Commissioner Green said to stay safe and get ready for spring.

Commissioner Singer walked the docks and noticed there are a few things to take care of.

Public Comments

Aaron Wenholz, long time tenant, is glad to see the agenda item "Survey" because he thinks it needs to be reassessed. He witnessed it isn't helping the Port and isn't working the way it was intended to. Good potential tenants are being lost because of it and exceptions need to be made.

Councilman Musgrove, Port Liaison, wondered if there was an update about the cancelled meeting between the Port and the City.

Ed Fernandez, tenant, wondered if there was a way to get people to turn their lights on who are anchored out in the bay.

Poulsbo Boater's Association

There was no report.

Consent Agenda

Old Business Items

Rules and Regulations Approval

Commissioner Singer said the Rules and Regulations have been discussed and worked on for a while. There was a meeting with the PBA and others at the Port. Changes have been made; reviews have been done. Port Accountant Tripp will send the Rules and Regulations electronically for the Commission to sign.

John Piccone Report

Mr. Piccone said everything is wrapped up with the breakwater and grants are being closed up now. Regarding E & F Dock updates: the bid documents have been fully completed and the project is out to bid. Advertising begins March 1st and will continue through March 15th. There are two ads that will be posted March 8th and March 15th in the local paper. Several contractors have already requested more information. The bid opening will proceed on April 4th. Mr. Piccone will update the board during the first meeting in April.

He anticipates May – August working with selected contractors with bonds, etc. September 5th will be the first day on-site construction can occur. He's anticipating 90 days of on-site construction with a fully concluded date of December 4th. During site work, all of E & F Dock, including the fuel barge, will be inaccessible and closed except for construction personnel. The rest of the Marina will remain relatively unaffected. The restrooms, laundry room, and PO Boxes will be available as pedestrian access only during the on-site work.

The floating restroom project was awarded to Topper Industries. Mr. Piccone is currently reviewing their shop drawings. He did receive the Corps permit, has reviewed all the permit documents, and was given notice to proceed. By the next boating season, everything will be up and running and available to the public.

New Business Items

Commissioner Responses to Public Comments/Discussions

Commissioner Lawrence agrees with the anchor topic. It's always a problem.

Commissioner Singer said Port has jurisdiction 198' past the new breakwater. After that it's county jurisdiction. All the Port can do is encourage people to turn their lights on. Regarding the waitlist, there are different waitlists: don't have a slip and waiting for a slip or waiting to move from one slip to another. He knows that new people are getting bumped to the bottom if they refuse an available slip. It's a topic he's thinking about, and people are coming to him to talk about it.

Boat Survey Policy

Eugene said this policy was done not too long ago and the original was amended. There was a problem with the way it was originally written that allowed the boater to say they had a choice whether the boat needed a survey or a safety letter. He rewrote the policy to say a survey is done after a certain age of the boat. If there's something in the survey letter that requires fixing, a safety letter would then be issued to address that specific issue.

Use of Port Tablet Policy

Port Accountant Tripp said with the breakwater opening in the next 3-4 weeks the Port has obtained a tablet and keyboard. A policy is needed to outline what is acceptable and appropriate for usage.

Motion: Move to approve the Port Tablet Policy with a three-year review. **Moved by:** Commissioner Singer **Seconded by:** Commissioner Green

Motion passed unanimously.

Accountant's Report

There was no official report. The state auditor office offers what is called the "Lean Program." Specialists from the office come and analyze products and offer solutions, and this is a free service. Port Accountant Tripp contacted their office and scheduled a meeting next Thursday with them to discuss how the breakwater will be operated, along with how to integrate E & F Dock.

Regarding John's comment on the closure of E & F Dock for 3-4 months: during that time, it is her suggestion to the board to lay off guest moorage staff during that time. She cannot justify that expense for 3-4 months. There will be someone out on the breakwater that will be able to take care of guest moorage. Guest moorage will only be available on the breakwater during the construction.

Maintenance: Eugene

- Breakwater has been pressure washed cleaned and tribal flupsy has been brought in. Maintenance was there to help facilitate any needs for the tribe.
- Ice Machine is ready for installation, power and water has been installed. The drain area has been prepped and we are awaiting the physical delivery of the machine.
- Breakwater directional signage has been installed as well as number plates and safety signs on the breakwater.

Guest Moorage: Jannese

- This month we have hit the ground running with interesting meetings. We met with Brian Kilpatrick to discuss finalizing the video with new footage of the breakwater. While discussing an event with (Brian) Evergreen Mountain Bike Alliance the potential for an event calling it "Bikes & Boats". A bicycle enthusiast overhead our conversation and asked to share information!
- We met with the Liberty Bay Festival Steering Committee. They were very interested to know how we organized the Frosty Fest Event. Many people think that it was organized by the HDPA. Our event also has been referred to as the Viking Winter Fest. They were surprised to learn that this event was organized by 4 ½ people! We will do our best to support their event.
- On Tuesday the lead organizers of the Nordhavn Rendezvous met with us to discuss their upcoming rendezvous over the Mother's Day Weekend. In addition to the new video, they will be filming they have asked Denise Whittaker from KOMO News to MC the event. This event will be hailed as the largest Nordhavn Rendezvous to ever be held. PORT OF POULSBO Kitsap County, Washington RESOLUTION 2024-02 DATED: MARCH 7, 2024

WHEREAS, the Board of Commissioners recognizes that the Port of Poulsbo has adopted a reserve policy; and

WHEREAS, the Port Accountant has reported that the annual revenue for the year ending December 31, 2023 totals \$3,846,382.11 with \$3,464,747.54 coming from General revenues and \$381,634.57 coming from Liberty Park revenues; and

<u>WHEREAS</u>, the reserve policy states that the initial minimum contribution into the Contingency Reserve Fund is to be 2.5% of the annual revenue.

<u>WHEREAS</u>, funds are not currently available in full, the Port Treasurer is directed to transfer funds immediately when they become available.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Port of Poulsbo, Kitsap County, Washington that the Port Accountant complete an Interfund Transfer in the amount of \$86,618.69 from the General Fund into the Contingency Reserve Fund and \$9,540.86 from the Liberty Park Fund into the Contingency Reserve Fund.
