Harbormaster Position Update

Harbormaster Trask said he was voted in as new harbormaster for the Port. He's looking forward to helping facilitate the Port along with the boating community, and the surrounding area.

Commissioner Comments

Commissioner Lawrence said summer is winding down. It's nice to see how busy it's been with all the boats out there. It looks like everybody is happy. The meetings are moving to Poulsbo Fire. He encouraged everybody to stay safe and enjoy what's left of summer.

Commissioner Green reported there is a Poulsbo Kids Event this Saturday. She reminded everybody September is Emergency Preparedness Month, so dust off plans.

Commissioner Singer said to check fire extinguishers. There are a lot of changes coming: E & F Docks are coming down; construction will be going on; the front office is moving out to the breakwater; the fuel dock will be closed; the parking lot will be unavailable, but the restrooms will remain open. Information will be put out to the public. He said it's been nice to have big boats coming into the Port. Everybody that he's talked to has said they're planning to come back. This is great for the Port and the City.

Public Comments

Loren Heights, end of A dock, isn't sure about what the policy is for derelict boats. There are boats sitting around and nobody is doing anything. The staff needs to be made aware of the policy, if there is one, so they can take care of derelict vessels. He also wondered if anything can be shared about the Port litigation.

Poulsbo Boater's Association

The association gave their report.

Old Business Items

Reservation Policy

There were no updates at this time. The item will remain on the agenda for the time being. A draft is expected within the next two months.

New Business Items

Commissioner Responses to Public Comments/Discussions

Commissioner Lawrence said, in reference to derelict vessels, there are policies in place as well as protocols that must be followed. The Port has programs and grants awarded, but there are certain times when money is collected to take care of things. Port Accountant Tripp has things in process, so now it's waiting for things to move along. Everyone at the Port helps one another. Being under government control means their staff has to be a bit more careful than private marinas. If someone sees a boat, please don't pull it in the marina. The boat can't just be put anywhere. While he wishes things were easier, there are rules that must be followed. The Port is doing what they can.

Commissioner Singer said if other boaters want to assist, they have to understand the full concern. The Port already has a policy regarding derelict vessels. The state also has a policy. Bringing a vessel into the Port makes the Port liable for that vessel. The Port has had to spend a lot of money on real derelict boats other the years. The first vessel addressed with the City was in City water, and crossed into Port waters. The boat can't be moved by a state employee because there are so many rules and regulations involved. There are liabilities to consider as a civilian as well. The board has had previous discussions about fees, and they've all been voted on and documented.

Accounting Report

Port Accountant Tripp confirmed the next meeting will be held at Poulsbo Fire. She encouraged people to attend via Zoom because the space is very small. Work on E & F Dock beings early morning on Monday, September 16th. Access to the dumpster and restrooms will be available, but the parking lot will be unavailable because that space is designated for project equipment.

Port Accountant Tripp has had very productive communication with the Mayor, who is receptive to releasing funds in the joint account with the Port to fix the bulkhead that is in need

of repairs. The audit for 2022-2023 has begun and should take no more than four weeks to complete. DBRP has the funding to destroy two derelict vessels in the Port. The summary financial statement for March 31st (emailed to Commissioners previously) shows July's net gain of \$11,716.18. YTD net gain is \$462,618.47. Port Accountant Tripp then briefly skimmed over the budget, which is not ready for the public just yet. The washers and dryers are passed their useful life. She found a laundry service that provides the machines, and the Port makes 51% of transactions made for use of said machines. This service has been added to the budget.

Port Accountant Tripp received a proposal from Marine Floats in Tacoma for the Dockmaster program. This involves coming in once a quarter and will provide ten hours' worth of repairs to docs in rotation. Anything extending past ten hours commits to paying at Marine Floats' rates. One caveat is that this does not include the breakwater. Harbormaster Trask can provide more answers and information about this program.

Public Comments & Requests for Future Agenda Items

Loren Heights, A Dock, wondered if the reservation policy will go on the website.

Jerry, AA-15, wondered about recycling bins and if there's a way to have them at the Marina.

Craig Muller, C-11, asked Port Accountant Tripp if the company supplying the washers and dryers are responsible for physical damage.

A City of Poulsbo resident within the Port District appreciates how the agenda and meetings are run at the Port. He's hoping the City and the Port can resume meetings once a year and hopefully tie the two entities back together to look at known issues.

Commissioner Comments

Commissioner Green said to get outside and enjoy the last bit of summer left. She also said to be safe and work on those emergency preparedness plans.

Commissioner Lawrence said recycling bins should be everywhere. We're not recycling properly. When the rules and regulations are updated, books are not distributed with the new rules. It's everyone's responsibility as civilians to educate themselves about the rules within government. He then said to stay safe and enjoy what's left of summer. He's looking forward to the rain. He will also go to the next PBA meeting.

Commissioner Singer thanked everybody for coming to the meeting. He enjoys working with everyone. The board is trying to work on things that come up, and there will be more to address tomorrow.
