Call to Order 7:00pm

Commissioner Comments

Commissioner Green gave a shoutout to Aaron for his hypervigilance and help with an event over the weekend. Poulsbo is coming alive with events and new shops. Viking Fest is right around the corner and a lot of activities. Girls Night Out looks like it was a success.

Commissioner Singer said the breakwater is coming along well and hopes everyone takes a look at it. He thinks the Port should have a ribbon cutting, and Port Accountant Tripp should be the one to cut the ribbon. He suggested moving the BBQ float over there and have a gathering. He also welcomed everyone in attendance.

Commissioner Rose said last week there was a good All Ports meeting. Executive The director at the Port of Kingston spoke about how they set rates. There was good information for commissioners to compare and contrast. That information will be passed along to Port Accountant Tripp. The director was very upfront about the fact that if a Port doesn't have a minimum of 6.5% a year, that marina is falling behind. Insurance for marinas will be going up 30-40% and we will need to factor that in. For all three of the Commissioners, we have a review of Port Rules and Regulations in October. That's plenty of time to do summer homework and to take a look at it. He did not have access to his email because it's been down. He was present at D Dock and that topic will be discussed. He debriefed with the Poulsbo Fire Department, Mathews Electric, and with the owners of the vessels. He isn't qualified to touch high voltage things and so he can't assume the job of handling that situation. There's a lot to go over, lessons learned, and emotions involved. He then read aloud the description of comments at the bottom of the agenda. He will not be ignoring anybody and will be taking notes so that the board can take action.

Public Comments

Frank said he has a concern with the proposed gates that will be on the finger piers. A problem he observed is people can get around the gate against the floats. There are 20 slips outside those gates. One of those is his. He's been at the Port for about 35 years and always had security. The public dock goes in, and now the security will be lacking, but he will be paying the same rate of mortgage. It opens a liability on the Port.

Jack, who owns the sixth boathouse, said the problem is providing public access to somebody who is paying for private access. This needs to be addressed.

Nora said the situation with the electrical issue is alarming in terms of safety. She'd appreciate some better protocol with safety.

Nico said she had a maintenance meeting with Eugene and Aaron sharing concerns with the marina and hopes they'll be taken care of with the new pressure washing. She hopes that what they've seen so far is not the final product. She is concerned with the hardscapes around the marina. She shared visuals as examples. For each item they brought to Eugene, he had a reason why it wasn't being taken care of and why he doesn't plan on taking care of it in the future.

Shannon wanted to share she has a boat on C Dock and had no idea what was happening on D Dock, which she finds alarming. There were new tenants on C Dock who weren't aware of marina rules. Their kids were swimming and paddle boarding. There was no notice that went out to Port tenants. She wanted to plead with the board to have a better communication protocol.

Aaron is a tenant of ten years and a live aboard. The Commission should have great pride in their accomplishment in the breakwater. There have been many changes of the guard with staff, and many employees have passed through the Port in the last 12 months. Underneath the surface there is mismanagement, ignorance, laziness, inaction, ego, nepotism, etc. In tonight's executive session, he hopes Commissioner Green will stand up and do what's right. To Commissioner Singer and Commissioner Rose, he asked that they set aside their egos and follow through with what needs to be done. To Port Manager Eugne Madayag, Aaron speaks for many not willing to step up: please step down from your position.

Mr. Lang wanted to express his concern regarding the safety ladder closest to his boat. It's broken and designed to hold the ladder out of the water and pulled down when needed. The latch holding it up is broke and the ladder is in the water all the time and is growing barnacles, which makes it useless. He is a personal injury attorney and said the Port is exposing itself to liability in its current state of operation.

BJ said when Eugene was promoted, he was excited for him. Unfortunately, that has devolved since he has taken the position and is acting rudely and disrespectfully toward his clients. Communication skills are poor at best. Eugene did not choose to turn off the power to D Dock. Both Eugene and Commissioner Rose acted with gross negligence which exposes the Port to liability, and also them personally. The other two Commissioners sweeping the event under the rug, they too know the level of incompetence because they choose to accept it.

(Difficult to understand – I only caught bits and pieces about Beatrice having concerns about safet, pollution, environmental, and something about a garbage receptacle.)

Jay is a business owner and homeowner in the Port district for seven years in the marina. (Very difficult to understand, muddled audio) Everything starts at the top with training. We are a place of destination and are known for that.

Old Business

Jenson Parking/HDPA

Eugene read Port Accountant Tripp's document stating facts about the topic. Commissioner Singer said it would be a specific group of individuals who could use the parking during the day. The Port wouldn't oversee the use of the parking spots. What will prevent people from parking there and allow spaces they lease to be available to employees? Commissioner Singer said looking at the cost, it's his belief that what's best is that the Port does not go forward with any agreement with DHPA with parking. Parking right now is an issue and doesn't want to create further issues with parking. He understands their concerns, but the Port can't take on a liability from it, the loss of income from it, nor be responsible for administration of it. He does not recommend signing a contract.

Commissioner Rose suggested offering a discount to employees (\$3 instead of \$7 for a day). Each employee and employer could create an account to set up reimbursement.

Commissioner Green agrees with Commissioner Singer. It's a lovey walkable city and they can park an extra block away and plenty of parking.

Motion: Move to deny the HDPA proposal to sign a contract for leasing spots in the Jenson Parking Lot, with the caveat to continue positive communication with them **Moved by**: Commissioner Singer **Seconded by**: Commissioner Green

Motion passed unanimously.

New Business Items

Commissioner Responses to public comments/discussions

Commissioner Singer said in order for the Port to get the grant for the breakwater, one of the requirements was public access. The public access is how the Port was eligible to apply for and receive the grant. There has been discussion about no gates, where the gates would go, design of the gates, gate styles, and nothing has been finalized about the exact position of the gates.

He encouraged people to share ideas and make a suggestion for what the Port does. It's not something the board didn't think about, and there was a lot of discussion about it.

Commissioner Green liked Nico's presentation and asked if she has a digital copy of the pictures provided. She requested the presentation be emailed to her. She welcomed Stuart to the PBA and requested his contact information. She said the board will investigate the debris. To Shannon Glass, she appreciated her speaking up about the child, safety, and contact. There's a risk with ground access. To Mr. Lang and his daughter, she appreciated them speaking up about the ladder. She thanked everybody for their comments.

Commissioner Rose speaks to the engineer regularly. There will be growing pains, things the board doesn't think of, and things they could do better. We will get there. You asked for it, we recognize it, we'll get it right. Let's work together. He thanked everyone for their comments so the Commission can work off them. He isn't aware of any retribution for reaching out to the board. The change in going to a planning meeting format mean four types of agendas utilized according to the RCWs. With public witnesses, there can be staff interactions which allows diving into specific issues such as planning, improvement, general maintenance, infrastructure, etc. It'll allow to see where any shortfalls are and worth with the staff to get those up. The format will allow the opportunity to concentrate on specific items. Regarding the electrical issue, Commissioner Rose offers a reason (not an excuse). He was called and he responded. He came down and saw the Fire Department deploying. The talked to lieutenant, asked for a status, and if there was any risk. He was told by the Fire Department everything was secure, and the pier is warm from sunlight. The Fire Department are electricians. But he asked them first. Then he came down and looked pedestal himself. He talked to two boat owners and wanted to make sure they were ok, and things were taken care of to their satisfaction. That was a positive, to his knowledge. Prior to arriving he called both Port Accountant Tripp and Eugene. In his 25 years around here, if we need a new process, communication is part of it. He wasn't positive, but he doesn't believe it's in anybody's contract with the union to be on call 24 hours. Doesn't make it right and that can change. He is not qualified, nor has the knowledge to safety touch electrical. He was told to get ahold of John Piccone and Mathews Electric. That's how he left it. First thing Monday morning he talked about after action report and the electrician who did the repair. They did not say the pier was an issue. He asked specifically about what was done, and if this was something that could have been attributed to Port maintenance. It was the result of incorrect work by an electrician. Is it going to be left to lie? Absolutely not. He understands insurance and liabilities. We've got the collective abilities and talents to do this right. We can do this. Please review the Port regs so we can eliminate what doesn't apply and add things that do apply. He appreciates everyone and things that are happening are part of community; it isn't always comfortable. We are working with the system that we have. He also doesn't necessarily like certain elements. The Port attorney is present and will be attending tonight's executive session.

Tenant Boathouse for Sale

Boat House 19 is for sale and the owner is providing first opportunity to buy it for \$70,000. It is not refloated. The boathouse must be refloated by the new owner. The Commission unanimously agreed not to purchase the boathouse.

Request for future agenda items and public comments

Craig (Greg?) wondered about the missing permanent parking signs in the Jenson lot. Port Accountant Tripp said there are 22 spots in the Jenson lot, and four additional spots for those who are gone long term. Eugene said the spots are under the flex parking, so permanent moorage can park there as a lessee. Commissioner Singer will communicate with Eugene about this because there's been a disconnect.

Councilman Musgrove asked the board to strongly reconsider the HDPA committee proposal. A lot of labor is going on there now. This is one of those silver platters, easy buttons, you don't get very often give him the opportunity to speak about reconsidering. This is a lot of work and effort directly at your primary job of economic development. It's a win-win.

Nico is part of the HDPA, seconds Councilman Musgrove comment, and suggests a special meeting with the HDPA to better understand the proposal. She has heard it compared to or as an excuse the tenants aren't taking care of their vessels so it's a way the Port doesn't have to take care of their hardscapes. It's not a right comparison because the tenants are literally paying to not have to worry about that stuff. Tenants are trusting the Port will take care of it. Tenants work tirelessly and just want to talk down the dock and not micromanage Port maintenance. Tenants want to see Port workers out there cleaning, doing their job, not worrying about whether it's wet outside. There was a dinghy theft a couple months ago and tenants were just made aware of it. That now makes three dingy thefts right outside the Port office. Security cameras are very inexpensive now.

Commissioner Comments

Commissioner Green thanked constituents and boaters for stepping forward and speaking up. She is equally upset and concerned about the liabilities to the Port, the repeated negligence, and mismanagement. She wanted to let everyone know their voices are heard by her, and she wants to continue advocating for them. She welcomed Stuart and hopes to gain some realignment.

Commissioner Singer said he wants to see the operating process request, and the process for emergency procedures. He wants to see the written inventory of all safety training of electrical equipment. We are working on docks, the ladders, there's money to spend, and minimum staff to perform the work. There are numerous lessees that do not clean and maintain their boat. He read aloud numerous maintenance rules lessees are not following. All lessees need to take care of their boats, follow the rules and regs. The Port needs to enforce maintenance and make maintenance better.

Commissioner Rose said relationships get messy. This is the way to get that back on track. He understands that emails and other things have gotten personal. He understands emotions and he is there and not going anywhere. He wants to have planning meetings and get strategy going to improve things.
